MEMORANDUM

Sub:- Offer of appointment to the post of Lecturer (Electronics & Communication Engineering) under the Directorate of Training & Technical Education, Govt. of NCT of Delhi.

On the recommendation of Union Public Service Commission, New Delhi Vide their letter No. F.1/40(12)/2018-R.V/SPC-II dated 06.01.2022, the Lt. Governor, NCT of Delhi is pleased to offer Mr. Aditya Kumar to the post of Lecturer (Electronics & Communication Engineering) in the scale of pay of Rs. 15,600-39,100/- + AGP Rs. 5400/-. Dearness and other allowances will be admissible under the rules governing the grant of such allowances in force from time to time.

The terms and conditions of appointments will be as follows:-

- 1) This post is GCS Group - "A" Gazetted (non ministerial).
- 2) The post is permanent but your appointment will be on temporary basis. Your claim for appointment thereto in substantive capacity will be considered in accordance with the rule in force.
- 3) Your services may be terminated on one month's notice from either side in accordance with the Central Civil Service (Temporary service) Rules, 1965, without assigning any reasons. The Appointing Authority, however, reserves the right of terminating your services forthwith or before the expiration of the stipulated period of notice by making payment to you of a sum equivalent to the pay and allowances for the period of notice or the un-expired portion thereof.
- 4) You will be on probation for one year from the date of appointment, which may be extended at the discretion of the competent Authority. On completion of probationary period satisfactorily, you will be considered for confirmation in the said post.
- 5) With regard to Leave, Traveling Allowances, Contribution to Provident Funds, and other service matters connected with service conditions, you will be governed by the rules and orders in force from time to time.
- 6) On joining the said post, you will be required to take an oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect.
- 7) If you are already employed, you will have to produce a relieving order from the employer or acceptance of resignation order from your employer.
- 8) You should note that your appointment will be provisional and subject to verification of the **qualification/Date of Birth/Matriculation certificate etc. inquiry of character antecedents through proper channels and fitness of Medical examination report** and that if any claim in this regard is found to be false or you are not found to be medically fit, your services will be terminated forthwith without assigning any reason and without prejudice to such further action that may be taken under the Indian Panel Code for production of false certificate. You should also intimate the change, if any, of your religion after appointment, immediately to the Appointing Authority/ Administrative Authorities concerned.
- 9) In accordance with the relevant rules in force in regard to the recruitment to service under the Government of India :-
 - a. No person who has more than one wife living or who having a spouse living, contract a second marriage, through such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to service, provided that the Government may, if satisfied that there are special grounds for doing so, exempt any person from the operation of this rule.
 - b. His/her spouse who is married to such a person whose wife is living at the time of marriage shall not be eligible for appointment in service unless the Government of India has granted exemption to such a woman in accordance with this rule after being satisfied that there are special grounds for so doing.
- 10) This offer of appointment is, therefore, conditional upon your satisfying the requirement and furnishing declaration in the form enclosed to this letter, alongwith your reply. If, however, you do not fulfill the above condition and you desire to be exempted from the above mentioned rules due to any reason, you should make a representation in this behalf immediately. This offer of appointment should in that case, be treated as cancelled and a further communication will be sent to you in due course.
- 11) The offer of appointment is further subject to your producing a medical certificate of fitness from the Medical Board Guru Teg Bahadur Hospital, Shahdara, New Delhi-110095.

- 12) If any declaration given or information furnished by you is proved to be false or if you are found to have willfully suppressed any material information, you will be liable for removal from service and other action, as Government may deem necessary.
- 13) If you accept this offer of Department on the above terms and conditions, you are requested to intimate your acceptance to the undersigned latest by within 30 days of issuing this letter with the following documents:-
- Duly filled Attestation in triplicate with attested copies of Education Qualification and Date of Birth Certificate by Gazetted Officer.
 - Declaration of marital status in the form enclosed.

You should also report to Guru Teg Bahadur Hospital, Shahdara, New Delhi: 110095 for medical examination.

- 14) It is also informed that UPSC vide letter No. F.1/40(12)/2018-R-V/SPC-II dated 22.10.2019 has conveyed the decision of Hon'ble High Court issued vide interim order dt. 27.05.2019 in W.P. (C) 5919/2019 titled Mohd. Fasih Ahmed and Ors. vs UPSC and Ors that "*The selection in question pursuant to advertisement challenged in the present petition shall be subject to the outcome of the present petition*".

Therefore, in compliance of Hon'ble High Court interim order dated 27.05.2019, Your appointment to the post of Lecturer (Electronics & Communication Engineering) shall be subject to the outcome of the present petition, directed by Hon'ble High Court, Delhi in W.P.(C) 5919/2019.




