ORDER

Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No. F.1(304)/DSSSB/P&P/2015/6123 dated 10.12.2021 and dated 13.12.2021 and being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** Hospital vide letter No. 39/08/02/2022 dated 03.02.2022, **Mr. CHANDER VEER SINGH, Roll No. 112311300011**, Category SC is hereby appointed to the post of **TECHNICAL ASSISTANT (PHARMACY)** in the **Revised in Pay Matrix Level-4 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time.
