
**ORDER**

Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No. F.1(418)/DSSSB/P&P/2018/6303 dated 30.12.2021 and dated 04.01.2022 and being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** Hospital vide letter No. 65/33/02/2022 dated 14.02.2022, **Mr. RAJEEV RAWAT**, Roll No. **112210400006**, Category **OBC** is hereby appointed to the post of **TECHNICAL ASSISTANT (ITESM)** in the **Revised in Pay Matrix Level-4 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time.
