Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No. F.1(309)/DSSSB/P&P/2018/6299 dated 29/12/2021 and dated 30.12.2021 and being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** vide letter No. 36/05/02/2022 dated 02.02.2022, **Mr. SUNNY PRASHAR, Roll No. 113511200015**, Category **UR** is hereby appointed to the post of **TECHNICAL ASSISTANT (ELECTRONIC & COMMUNICATION)** in the **Revised Pay Matrix Level-4 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time.
