ORDER

Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No.F.1(301)/DSSSB/P&P/2015/68 dated 18/01/2022 and dated 19.01.2022 being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** vide letter No. F.4/GTBH/MD/SP/ME/19/10141 dated 23.02.2022, **Mr. DEEPAK KUMAR, Roll No. 112510800076, Category OBC** is hereby appointed to the post of **TECHNICAL ASSISTANT (MECHANICAL)** in the **Revised in Pay Matrix Level-4 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time. 
