
ORDER

Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No.F.1(301)/DSSSB/P&P/2015/68 dated 18/01/2022 and dated 19.01.2022 being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** vide letter No.F.4/GTBH/MD/SP/ME/19/10141 dated 23.02.2022, **Mr. NAND KISHOR**, Roll No. **112310800047**, Category **SC** is hereby appointed to the post of **TECHNICAL ASSISTANT (MECHANICAL)** in the **Revised in Pay Matrix Level-4 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time. His candidature is purely provisional and subject to fulfilling all the conditions of eligibility for the post and on the following terms and conditions:

The candidate is directed to furnish an undertaking to this effect at the time of joining of duties, failing which the candidate shall not be allowed to join duties.
