Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No.F.1(301)/DSSSB/P&P/2015/68 dated 18/01/2022 and dated 19.01.2022 being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** vide letter No. F.4/GTBH/MD/SP/ME/19/10141 dated 23.02.2022, **Mr. GULSHAN KUMAR**, Roll No. **111410800008**, Category **SC** is hereby appointed to the post of **TECHNICAL ASSISTANT (MECHANICAL)** in the **Revised in Pay Matrix Level-4 Rs. 5200-20200**; plus usual allowances as admissible under the rules from time to time. His candidature is purely provisional and subject to fulfilling all the conditions of eligibility for the post and on the following terms and conditions:

1. The appointment is fully governed by the terms and conditions already conveyed to the candidate in the offer of appointment dated 24.01.2022 duly accepted by his vide letter dated 25.01.2022.
2. The appointment is provisional and subject to verification of his character and antecedents by the concerned Police Authorities.
3. The appointment is provisional and is subject to the caste/tribe/community certificate being verified through proper channels and if the verification reveals that the claim to belong to Scheduled Caste/Scheduled Tribe/Other Backward Class, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

The candidate is directed to furnish an undertaking to this effect at the time of joining of duties, failing which the candidate shall not be allowed to join duties.


