Consequent upon selection to the post of Lecturer (Electronics & Communication Engineering) by the Union Public Service Commission and after having been declared medically fit for entry into Govt. Service by the Staff Physician, Guru Teg Bahadur Hospital, Shahdara, Delhi, the Hon'ble Lt.
