
MEMORANDUM

Vide this office memorandum no. No. F.1/1293/TA/E-1/TE/AD/131-36 dated:14.01.2022 an offer of appointment was issued to Sh. Jitendra s/o Sh. Sarman Singh to the post of Technical Assistant(Pharmacy) and on his acceptance, he was referred for medical examination and subsequent declared medically fit by the Staff Physician, GTB hospital, Shahdara, GNCTD, subsequently, an appointment letter was issued to Sh. Jitendra vide this office order vide this office order No. F.1/1293/TA/E-1/TE/AD/761-766 dated:09.03.2022 within 21 days was directed to report for duty at the DTTE (HQ). Subsequently, reminder-I No. F.1/1293/TA/E-1/TE/AD/1290-1264 dated: 27.04.2022, reminder-II No. F.1/1293/TA/E-1/TE/AD/1489-1493 dated: 23.05.2022, third/final reminder No. F.1/1293/TA/E-1/TE/AD/1580-1584 dated: 08.06.2022 and one month extension order no. F.1/1293/TA/E-1/TE/AD/1752-55 dated:30.06.2022 to join for duties to the said post. Despite all these efforts, no further communication of any kind has been received from him till date and candidate failed to join for duties in this office.
