

1.	Does all the Gazetted Officers of DTTE and its attached offices mark biometric attendance.	The applicant has asked certain questions / queries in the disguise of seeking information under RTI Act. Asking of questions and raising of queries is not covered under the definition of "Information", as provided under Section 2(f) of RTI Act, hence the questions raised by the applicant cannot be replied, as per provisions of RTI Act.
2.	If there is any gazetted officer of DTTE or of its attached offices who does not mark biometric attendance.	
3.	If the response of question at S. No. 2 is yes, then what action has been taken against such officer.	
4.	Is there any order of any Govt. body which exempts Gazetted Officers from marking biometric attendance. If so, provide the attested copy of the same.	
5.	Has Director DTTE ever taken note whether rotation of purchase officer which is a sensitive post is being regularly made in its attached offices and ITIs. If yes, copy of the documents and if not reason therefore.
