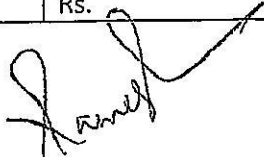

4. The payment is to be made institute wise and office of DTTE & BTE through Principal/D.D.O., concerned/H.O.O. after the providing outsource Services by the Service Provider.
5. This issued with approval of the Secretary (TTE) and in concurrence with the accounts functionary of the department vide U.O No.680 DTTE (H.Q.)(A/cts) dated 18.02.2026
6. Actual wages are to be paid to Security & Sanitation Personnel on their attendance basis.
