

• Age limits as on 16.12.1999. Relaxable for displaced persons, Ex-Servicemen & Commissioned Officers incl ECs/ SSCs/ Meritorious Sportsmen/ Sportswomen/ Widows, divorced women, women judicially separated from their husbands, who are not remarried as per Govt orders issued from time to time. Age relaxation of 5 yrs admissible to those who had ordinarily been domiciled in State of J&K during period from 1.1.1980 to 31.12.1989 subject to submission of certificate from District Magistrate of area or from any other authority designated by Govt in this behalf. Age is relaxable upto 5 yrs for SC & ST Candidates and upto 3 yrs for OBC Candidates for posts resvd for them. For Govt Servants age is relaxable upto 5 yrs unless stated otherwise.
