MEMORANDUM

Whereas, Ms. Sucheta Garg (DOB: 18.03.1998) D/o Mr. BABU RAM GARG, has been provisionally nominated by the DSSSB vide result notice dated 01.04.2022 and an offer of appointment to the post of Technical Assistant (Interior Design) was issued to her vide this Office Memorandum No. F.1/1304/TA/E-1/TE/AD/1671-76 dated 02/06/2022, subject to verification of educational qualification and was given an opportunity to submit her acceptance to the offer of appointment to the undersigned within 21 days from the date of issue of the memorandum and report personally along with relevant documents.

And whereas, during the time of document verification at DTTE (HQs) by the concerned subject expert, the affiliation details of the Institute i.e. YMCA, New Delhi from where Ms. Sucheta Garg acquired her diploma was found doubtful.

And whereas, a letter addressed to General Secretary, YMCA was issued to verify the educational qualification acquired by Ms. Sucheta Garg i.e. Diploma in Interior design and its affiliation status from YMCA, New Delhi vide letter no. F.1/1304/TA/E-1/TE/AD/1811-13 dated: 08.07.2022 and reminder-I F.1/1304/TA/E-1/TE/AD/2336 dated: 23.08.2022 to verify the educational qualification acquired by her i.e. Diploma in Interior Design from YMCA, New Delhi and its recognition.

And whereas, the reply received from Executive Director, YMCA, that whether YMCA, New Delhi is affiliated with UGC/AICTE or any other recognized board was not satisfactory and no evidence was submitted by YMCA, New Delhi regarding its affiliation with UGC/AICTE or recognition from any state board.

And whereas, a letter no. F.1/1304/TA/E-1/TE/AD/2532 dated 28.09.2022 and subsequent reminder no. F.1/1304/TA/E-1/TE/AD/3134 dated 10.11.2022 was issued to Ms. Sucheta Garg with request to submit evidence to prove that her qualifications in Interior Design was acquired from recognized Institute affiliated with UGC/AICTE or any other recognized board within 15 days of issuance of that letter. However, no evidence has been received from her till date.

Therefore, in view of the above facts, circumstances and in light of RRs for the said post, the candidature of Ms. Sucheta Garg (DOB: 18.03.1998) D/o Mr. Babu Ram Garg to the post of Technical Assistant (Interior Design) is hereby rejected, offer of appointment bearing No. F.1/1304/TA/E-1/TE/AD/1671-76 dated 02/06/2022 issued for document verification is hereby stands cancelled and e-dossier returned to the DSSSB, GNCTD and no further correspondence in this regard will be entertained by this office.
