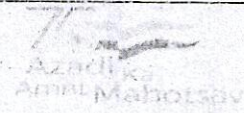

ORDER

Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Government of NCT of Delhi vide letter No. F.1(433)/P&P/DSSSB/2018/452-454 dated 02.05.2023 dated 04.05.2023 and being declared Medically Fit by Chairman of Medical Board, GTB Hospital vide letter No. F.3/GTBH/MD/SP/ME/3875 dated 16.08.2023, Mr./Mrs./Ms. Arun Kumar Meena, Roll No. 112501201322, Category ST is hereby appointed to the post of LABORATORY ATTENDANT in the Revised in Pay Matrix Level - 2 Rs. 5200-20200 plus usual allowances as admissible under the rules from time to time. His/her candidature is purely provisional and subject to fulfilling all the conditions of eligibility for the post and on the following terms and conditions:
