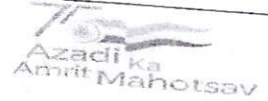

In continuation of this Office Memorandum No. F.1/1329/TA/E-1/TE/AD/3463-3468 dated 08.12.2022, vide which an offer of appointment was issued to Mr. Vivek Chauhan (Roll No. 121200900016) for the post of Technical Assistant (Modern Office Practice) Hindi (Post Code 9/21) in pursuance to recommendation received from DSSSB vide through e-appointment.

Subsequently, during the time of documents verification, the candidate has failed to produce the requisite/essential qualification as per the Recruitment Rules & requisition Proforma i.e. Diploma in MOP(Hindi) or Bachelor's degree with one of the subject in office management or Secretariat ship.

In this connection, three opportunities vide deficiency memo dated: 07.03.2023 dated 20.04.2023 and 21.07.2023 were given to the candidate. However, the candidate has not submitted the requisite document within the reasonable stipulated time.

The above act on the part of the candidate is considered as refusal to submit the requisite documents and it is presumed that the candidate is not interested in the appointment to the post of TECHNICAL ASSISTANT (Modern Office Practice) Hindi in Level 4 Pay Matrix (Pre-revised Pay Band - 5200-20200 with Grade Pay of Rs. 2400/-) plus usual allowances as admissible under the Rules.

Accordingly, the offer of appointment to Mr. Vivek Chauhan hereby stands cancelled. No further correspondence in this regard will be entertained by this department, in future.
