Whereas vide this office memorandum No. F.1/1316/TA/E-1/TE/AD/1900-05 dated:18.07.2022 **Sh. Mohit Dabas S/o Sh. Surender Kumar** was issued an offer of appointment to the post of Technical Assistant (Computer).

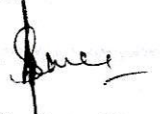
And whereas, during the time of document verification at DTTE (HQs) by the concerned subject expert, the curriculum of educational qualification acquired by **Sh. Mohit Dabas** was found doubtful.

And whereas, a letter dated 15.09.2022 and subsequent reminder dated 17.11.2022 were issued to concerned University i.e. Delhi university to verify the educational qualification acquired by **Sh. Mohit Dabas** i.e. B.SC(Physical Sciences), but no relevant response has been received till date.

And whereas, a letter no. F.1/1316/TA/E-1/TE/AD/2151 dated:21.07.23 and subsequent reminder no. F.1/1316/TA/E-1/TE/AD/2531 dated 24.08.23 were issued to **Sh. Mohit Dabas** with request to submit evidence to prove that his qualification is equivalent to the post of Technical Assistant(Computer) in light of extant RRs. However, no evidence has been received from him till date.

Therefore, in view of the above facts and circumstances as well as in light of RRs for the said post, the candidature of **Sh. Mohit Dabas S/o Sh. Surender Kumar** to the post of Technical Assistant (Computer) is hereby rejected. The offer of appointment vide letter No. F.1/1316/TA/E-1/TE/AD/1900-05 dated:18.07.2022 issued for document verification also stands cancelled and e-dossier is returned to the DSSSB, GNCTD. No further correspondence in this regard will be entertained by this office.
