MEMORANDUM

In continuation of this Office Memorandum No. F. F.1/1351/LA/RCTT/E-1/2023/1449 dated 30/06/2023, vide which an offer of appointment was issued to **Mr. RAJAT (DOB: 28.01.1998)** S/o **Mr. YOGENDER SINGH** and subsequently, after accepting the offer of appointment issued to him, the candidate was referred for medical examination.

As per the information received from Staff Physician, GTBH, Shahdara, GNCTD, vide letter dated 18.12.2023 **Mr. RAJAT** has **not reported** for medical examination at the hospital.

Subsequently, a reminder/final opportunity vide letter no. No. F.1/1352/LA/RCTT/E-1/2023/302-304 dated: 11.01.2024 was given to the candidate to appear for the medical examination and as per information received from Staff Physician, GTBH, Shahdara, GNCTD, vide letter no. F.3/GTBH/MD/SP/ME/1654 dated 19.07.2024 **Mr. RAJAT** has **not reported** for medical examination at the hospital.

The above act on the part of the candidate is taken as refusal to go through medical examination and it is presumed that the candidate is not interested in the appointment to the post of **Laboratory Attendant** in Level 2 Pay Matrix (Pre-revised Pay Band - 5200-20200 with Grade Pay of Rs. 1900/-) plus usual allowances as admissible under the Rules.

Accordingly, the offer of appointment issued to **Mr. RAJAT (DOB: 28.01.1998)** S/o **Mr. YOGENDER SINGH** hereby stands cancelled. No further correspondence in this regard will be entertained by this department, in future.
