Consequent upon the recommendation of the Delhi Subordinate Service Selection Board, Govt. of NCT of Delhi vide letter No. F.1(433)/P&P/DSSSB/2018/452-454 dated 02.05.2023 dated 04.05.2023 and being declared **Medically Fit** by Chairman of Medical Board, **GTB Hospital** vide letter No. F.3/GTBH/MD/SP/ME/1654 dated 19.07.2024, **Mr. Rajat Garg**, Roll No. 111501200916, Category **UR-PH-VH** is hereby appointed to the post of **LABORATORY ATTENDANT** in the **Revised in Pay Matrix Level - 2 Rs. 5200-20200** plus usual allowances as admissible under the rules from time to time. 
