Those officials who have been granted MACP benefits in Rs. 2800/- G.P are not eligible for any increment at the time of pay fixation on grant of NFSG benefits in terms of DoPT, Govt. of India OM No. 25/7//2019-CS.II(B) dated 27.08.2019, which has been endorsed by Services Department dated 02.02.2021 and accordingly, only the difference in Grade Pay (i.e. 4200-2800=1800) should be allowed.

The above mentioned officials are allowed to exercise their option, if any, under FR 22 within one month of the issuance of this order granting the Non Functional Selection Grade. Further, Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from their pay and also in future, due to addition or deletion of names in the eligibility list, they will have no claim over the date of eligibility.
