The first appeal was heard on 15th January, 2025 at 03:00 P.M.

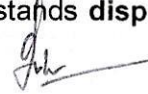
Present: - SO (Vigilance)/LO, Custodian of records/representative of deemed PIO from Vigilance Branch, DTTE (HQ).

Appellant was also present.

Submissions of the appellant and documents available on record are perused. It is observed that the RTI application of the applicant was transferred to the PIO, College of Art, GNCTD under section 6(3) of the RTI Act, 2005 vide DD (Vigilance) letter dated 22/11/2024 & SO (SB) letter dated 11/11/2024 and appellant was also informed about the same by the PIO, DTTE(HQ) vide letter dated 27/11/2024. Also, as conveyed by the Vigilance Branch, DTTE (HQ) vide its letter dated 07.01.2025 the ICC report dated 21.10.2024 along with all documents has been remitted back to the College of Arts, vide their office letter dated 03.01.2025.

Further, during the course of hearing, order dated 10/12/2024 of the FAA, College of Art, GNCTD is also perused and it is observed that FAA, CoA has no authority to issue directions to the CPIO, DTTE (HQ) to provide the information to the appellant.

In view of above, the appellant is advised to approach the PIO, CoA or the FAA, CoA to seek requisite information as per provision of the RTI Act or If the appellant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 within the stipulated time i.e. 90 days as per RTI Act 2005 against the order dated 10/12/2024 of the FAA, CoA. This Appeal stands **disposed off**, accordingly.
