The concerned officials may be allowed to exercise their options for fixation of pay under FR-22(1) (a) (1) within one month of the issuance of this order.

The grant of higher pay scale under MACP, is subject to verification of Audit and also subject to the undertaking that in the event of overpayment, the same may be recovered from their pay. Financial up-gradation under the MACP Scheme shall be purely personal to the employee and shall have no relevance to his seniority position. As such, there shall be no additional financial up-gradation for the senior employees on the ground that the junior employee in the grade has got higher pay/grade under the MACP Scheme. No stepping up of pay in the pay band or Grade Pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme.
