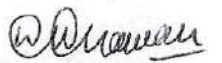
The engagement will only be on present functional requirement, purely temporary on hourly basis and for the **Academic Session 2025-26 only**. It shall not be taken as precedent for any other relevant matter. Further, the services of a PTI may be terminated at any time during the academic session if the functional requirement ceases to exist, or in the event of any reported disciplinary proceedings/action. The Principal(s) / Vice Principal(s) (H.O.O.) concerned are directed to take necessary action in this regard and are further directed to immediately inform this branch if there is any Part Time Instructor found to be surplus as per the Present functional requirement (which may vary after closure of admission process) in their Institute for the Academic Session 2025-26.

The Principals/Vice Principal(s)/HOO are also directed to follow and convey the instructions to PTIs as mentioned in the Circular dated 25.05.2025 regarding dis-engagement of PTIs.

The Principal(s) / Vice Principal(s) (H.O.O.) concerned are further directed to ensure that One Part Time Instructor will be engaged on the basis of need of the institute up to a **maximum assignment of two slots (16 hours each) per week** (Refer Office order issued vide file No. 7(19)/Acad/1038/PTI/2016-17/920 dated 23/06/2016 (Copy enclosed for ref.)).

The Principal(s) / Vice Principal(s) (H.O.O.) concerned will also schedule and assign the time table for the Part Time Instructors (PTIs) giving them the classes at a stretch without any break / long break (i.e. between theory classes and practical classes). Principal(s) / Vice Principal(s) (H.O.O.) concerned shall ensure that all the Part Time Instructors are informed that they shall leave the institute immediately their classes / duty are / is over and after marking the departure attendance as per prescribed procedure.

NOTE: All the candidates to be engaged as Part Time Instructors (PTIs) (temporary on hourly basis) shall note that merely mentioning their number / name in the above order shall not give them right to claim their engagement as PTI in any of the Govt. Industrial Training Institute, Delhi under the administrative control of Department of Training and Technical Education. They can only be engaged if Present functional requirement is there in any concerned Institute and in their relevant Trade. Part Time Instructors shall be paid remuneration in accordance with the details mentioned in the enclosed offer of Engagement at **Annexure-A**, and Principal(s) / Vice Principal(s) (H.O.O.) concerned will make the payment of remuneration to the Part Time Instructors so engaged against sanctioned post.

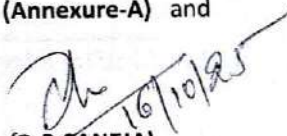
