The concerned officials may be allowed to exercise their options for fixation of pay under FR-22(1) (a) (1) within one month of the issuance of this order.

The grant of higher pay scale under MACP, is subject to verification of Audit and also subject to the undertaking that in the event of overpayment, the same may be recovered from their pay. Financial up-gradation under the MACP Scheme shall be purely personal to the employee and shall have no relevance to his seniority position. As such, there shall be no additional financial up-gradation for the senior employees on the ground that the junior employee in the grade has got higher pay/grade under the MACP Scheme. No stepping up of pay in the pay band or Grade Pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme.

However, before granting actual financial benefits (arrears) of financial up-gradation under MACP Scheme, the Head of Office concerned may confirm that the officials concerned have completed requisite period of regular service and are clear from Vigilance angle and check the service particulars of officials mentioned against their name. If any discrepancy is noticed, same may be brought to the notice of this Branch immediately, failing which, responsibility will rest upon them.
