

ORDER

In continuation of this Office Memorandum No. F.1/1440/LA/RCTT/E-1/2025/128-133 dated 11.03.2025, an offer of appointment had been issued to **Mr. Abhishek Verma (DOB: 22.05.2001), S/o Brijesh Kumar Verma**, for the post of Laboratory Attendant in Level-2 of the Pay Matrix (pre-revised Pay Band ₹5200-20200 with Grade Pay ₹1900) along with other allowances as admissible under the applicable Rules.

In pursuance of the said appointment offer, Mr. Abhishek Verma was repeatedly directed to report for medical examination at GTB Hospital, Dilshad Garden, New Delhi-110095. For this purpose, the following communications were issued to him:
