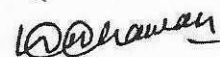
Sub: Re-assignment of Seniority in the Seniority List of Group Instructors (G.I)

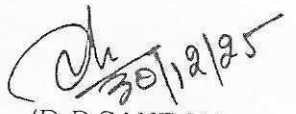
