It is further requested to kindly encourage all officers/officials of your branch for self-enumeration for the phase-I of Census, 2027, during the notified period of 15 days i.e. from 1st April, 2026 to 15th April, 2026 in the area falling under New Delhi Municipal Council (NDMC) and Delhi Cantonment Board and from 1st May, 2026 to 15th May, 2026 in Municipal Corporation of Delhi (MCD) for wide scale participation of general public at large.
