2. That PIO, instead of responding to my RTI request under section 6(3), transferred it to PIO College of Art, New Delhi. Curiously, on the day before the deadline, PIO College of suddenly recognized that the request was unrelated to his office and transferred it once more to PIO DTTE (HQ). This act demonstrates how skilled they are at playing hide and seek and how nicely they are poking fun of this Act through this game.


