Submissions of Appellant & representative of custodian of records are heard to the depth and documents available on the record are also perused. The appellant deliberated that as per 6<sup>th</sup> CPC, AICTE the age of superannuation was 62 and in 7<sup>th</sup> CPC AICTE, nothing is mentioned about this category of post and so his plea was that age of superannuation of 62 to continue. To find clarity in the matter DD(E-I) is suggested to sought clarifications from AICTE about age of superannuation of Librarians working under Diploma Level Technical Institutions and provide copy of letter to the applicant in the instant RTI application.

Appeal disposed off, accordingly. If appellant is not satisfied with this direction, he may file second appeal before Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg Munirka, New Delhi - 110067 within the stipulated time.
