In reference observations of Hon. Chief Minister, It is submitted that the members of the Screening committee recommended that relaxation of guidelines of requirement of First class either at Undergraduate or Post graduate level for the grant of Selection Grade may be considered on the following grounds :

1. AICTE has not issued any clarifications in response to the various requests /DO letters of Pri. Secy(TTE) forwarded by the Department for the grant of Selection Grade to this category of Lecturers.
2. It is found that all the three officers under this category posses more than 65 marks out of 100 in the results of profile evaluation (344-347/16). These results were kept in a sealed cover as per the recommendations of the committee in the last meeting held on 17.02.2011(261/c : Minutes of the meeting).
3. In the similarly placed cases, Delhi Technological University has granted Selection Grade Scales.
4. These Lecturers cannot improve their grades or classes or division in their Undergraduate/Post Graduate Degrees at this stage.

Keeping in view of these recommendations of the Screening Committee, Hon. Chief Minister may consider the relaxation in the guidelines for granting Selection Grade in respect of Sh. C.Kennedy: Lecturer(Electrical), Sh. P Ramanalah : Lecturer(Computer Science and Engg) and Sh. Ravinder Singh : Lecturer(Electrical Engg).

If approved, following proposals may be placed before the Hon. Lt. Governor for his kind consideration and approval :

- Sh. C.Kennedy, Sh. P Ramanalah and Sh. Ravinder Singh may be granted Selection Grade by relaxation of guidelines of requirement of First Class either at the Undergraduate or Post Graduate level.
- Sh. K.C. Chaudhary may be granted upgraded AICTE scale : 3700-125-4300 (Prerevised) w.e.f. 13.7.88 and revised AICTE scale of 12000-420-18300 w.e.f. 1.1.1996.

Minutes of the meeting are also placed at 340-343/c for approval.
