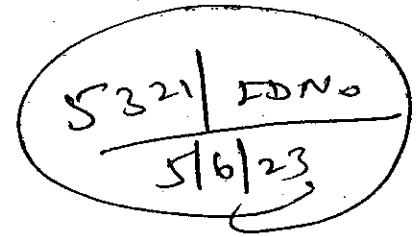


Sir/ Madam,
