

On the recommendations of the Review Departmental Promotion Committee, the Competent Authority is pleased to appoint the following Grade-III(GNCTDSS)/Sr. Asstt. Official on promotion to the post of Grade-II(GNCTDSS)/Asstt. Section Officer in level 07 of pay matrix of pay scale of Rs. 44900-142400 (Pre-revised Rs.9300-34800 with grade pay Rs.4600/-) notionally w.e.f. the date mentioned at Column No. 6 under Rule 6 of DASS Rules, 1967:-

The official may exercise his option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order. However, the financial benefits will be admissible to the above mentioned official with effect from the actual date of joining to the post of Grade-II and no arrear will be allowed for the period he has not actually worked as Grade-II.

On promotion, the official will continue to work in TTE to the post of Grade-II and his salary will be adjusted against a vacant post of Grade-II from Education Department.

The promotion is subject to the condition that the Head of the Departments concerned must ensure that no disciplinary proceedings/criminal proceedings was pending or no penalty was in operation against the promotee official on the date of his notional promotion before relieving him to take up his new assignment on promotion in the light of instructions contained in DoPT O.M. No.22011/4/91-Estt(A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in his relieving order as well. Further, an undertaking in this regard shall also be obtained from the official concerned by the administrative department concerned before relieving to his new assignment on promotion.

If the above official, is not clear from vigilance angle or his integrity is not certified as on date or has resigned/ expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Further, in the case of PwBD official, HOD concerned may ensure the authenticity of PH certificate, issued by the competent medical authority and may be got verified/re-verified at the time of appointment as per instructions contained in para 2.3 of the DoPT's O.M. No. 36/012/1/2020-Estt.(Res.-II) dated 17/05/2022.

Attention of Head of Department's is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his promotion within a period of three months in any case.

Furthermore, in the light of instructions contained in para 5 of DoPT's O.M. No.36012/16/2019-Estt.(Res.) dated 12/04/2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.
