उपरोक्त आर.टी.आई. का उत्तर DTTE Letter No. F.2(16)/2006/RTI/TTE/ ID No. 5339/801-02/4666 Dated 13/09/2023 और DTTE Letter No. F.1/1362/E-1/RTI/2023/DTTE/2782 Dated 12/09/2023 के द्वारा मुझे प्राप्त हुआ है ।

प्रश्न संख्या 1 से संबंधित जानकारी DD (E-1) द्वारा यह लिखकर उपलब्ध नहीं कराई गई है कि कैबिनेट के कागजात गुप्त दस्तावेज होते हैं, कैबिनेट कागजात को आरटीआई अधिनियम, 2005 की धारा 8 (1) (i) के तहत प्रकटीकरण से छूट दी गई है ।

महोदय, मैं आपके संज्ञान में लाना चाहता हूँ कि उपरोक्त आरटीआई के तहत मांगी जानकारी हमारी सर्विस कंडिशन/पे स्केल से संबंधित है क्योंकि Council of Ministers द्वारा कैबिनेट नोट पास/स्वीकृत हो जाने के बाद ही Department of Training & Technical Education, Delhi द्वारा हमें स्लेक्शन ग्रेड आदि देने की प्रक्रिया पूर्ण की जाती है । इसलिए कैबिनेट नोट में विभाग द्वारा जो स्वीकृति ली गई है, इसकी जानकारी अधोहस्ताक्षरी के लिए आवश्यक है । कैबिनेट नोट पढ़ने के बाद ही अधोहस्ताक्षरी स्लेक्शन ग्रेड नहीं मिलने का सही कारण पता कर पाएगा ।
