

Sir,

I want draw your kind attention towards the monopoly of Ms. Ruchi Bali AAO/DDO of Govt. ITI Mangolpuri. She is working as Assistant Accounts Officer as well as DDO of ITI Mangolpuri from 2016 to till date. She is continuously doing the misuse of the power of AAO/DDO in her personal benefit. She disbursed many bogus LTC bills of some officials and herself also by set aside the rules in lieu of bribe. This misappropriation was pointed out by the Audit Party in August 2019. An Audit Memo no 2 dated 07.08.2019 was issued to the Principal of Govt. ITI Mangolpuri having diary no. 517 dated 07.08.2019 (Copy Attached). This time also she played the tricks by misinterpreting the facts and succeeded to protect herself and other and other officials from the recovery of bogus LTC bills.

In this matter, recently an order of DIRECTORATE OF VIGILANCE, GNCT of Delhi File No. 1/12/DOV/Admn./2021/7098-7120 dated 21.06.22 has been released (Copy Attached). So, in the light of this DOV letter it is requested that a high level Vigilance Inquiry may be done against Ms Ruchi Bali AAO/DDO ITI Mangolpuri. And all recovery of Govt. Money (which she wrongly disbursed) may be done from the pocket of Ms. Ruchi Bali and appropriate action may be initiated against her. My complaint is in public domain.
