<b>Text of RTI Application :</b>	<p>Sh. O. P. Shukla was relieved on 28.08.2023 as a Joint Director (TTE) to join the post of Registrar, DIPSRU, by hiding his original designation of Lecturer (Civil Engg.) to justify his appointments as Registrar. Although he was not fulfilling the RRs of Registrar, DIPSRU. On 01.09.2023 he was again called on diverted capacity in the parent DTTE HQ to work as Joint Director (Plg.) against the rule of law. Whereas the post of Joint Director (Plg.) has not been created in the DTTE HQ to date. It shows nepotism and alleged corruption with the collusion of some of the administrative authorities of DTTE HQ and against the public interest. Hence, please provide the following information under RTI Act 2005:</p> <ol style="list-style-type: none"><li>1. Please provide the details of the work performed by Sh. O. P. Shukla during his stay at DPSRU as Registrar.</li><li>2. If Sh. O. P. Shukla during his stay at DPSRU as Registrar involved in the recruitment process, please provide the details including expenditure incurred in recruitment.</li><li>3. It come to know that he has filed a writ in the Honourable High Court of Delhi to extend his deputation at DPSRU whereas he has already completed his maximum deputation period permitted in law before joining the post of Registrar at DPSRU. Hence please provide the certified copies of the writ in public interest</li></ol>		

so that facts can be known from his writ.

4. Since he has already completed his maximum deputation period permitted in law before joining the post of Registrar at DPSRU he has given wrong information in his application to grab the post of Registrar at DPSRU. Please provide the details of the inquiry and action taken against him for hiding the facts.

5. Please provide the certified copies of correspondences made by DTTE with DPSRU in respect of Sh. O. P. Shukla after relieving Sh. O. P. Shukla from the post of Registrar.
