It is observed that the PIO has forwarded the reply received from the S.O. (Vig.) to the appellant vide letter dated 25/10/2023. The information sought vide Sr. No. 1,2 & 3 is not available in Vigilance Branch, as such, S.O. (Vig.) has rightly informed the appellant. However, it is noticed that the information at Sr. No. 4 is not concerned with the Vigilance Branch as the appellant informed that the same is related to reimbursement of his medical bills.

Therefore, S.O. (E-II) is directed to provide the information w.r.t. to the point No. 4 of the RTI application within 4 weeks from today being the Establishment branch in the policy matters related to the ITIs.

Appeal disposed off, accordingly. If appellant is not satisfied with the directions, she may file second appeal before Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg Munirka, New Delhi - 110067 within the stipulated time i.e. 90 days as per RTI Act 2005.
