3. Please provide me the certified order copy of last issued MACP by department to craft instructor/Group instructor / work shop attendant (Non- gazette cadre) .
4. Please provide me the certified list of all Government officials MACP dues up to 31st Dec 2022 after complete of service 10th/20th/30th year of service, if vigilance clearance /Integrity certificate /Work conduct report is cleared up to 31Dec 2022.
5. Please provide me the certified list of retired officials CI's/GI's /WSA in between the period from Jan 2022 to till as on date Nov 2023 without getting MACP on due date.
6. Please provide me the certified photocopy of action taken report of complete noting sheet / correspondence sheets of file ACP/MACP/TRG/Admn from NG Branch for those Government officials whose MACP dues up to 31st Dec 2022 after complete of service 10th/20th/30th year & (VC/IC/WCR) is also cleared in between the period from Jan 2022 to 31st Dec 2022 , as my MACP dues from 20-02-2022.
7. Please provide information to me the reason for non issue of MACP by NG branch after the issued last MACP order to all officials CI's/GI's/WSA on due date to those officials whose VC/IC/WCR is cleared up to 31st Dec 2022, before retirement or serving in department .
