

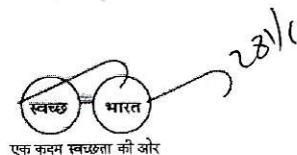

P Bhatti, DANICS (P) retired, during my posting at Delhi institute of Pharmaceutical Sciences and Research (DIPSAR), Mehrauli-Badarpur Road, Puspvihar Sector 3 New Delhi 110017 had dealt a corruption case, thereby, a loss of Government Exchequer to the tune of Rs.47,00,000/- (Rupees Forty-Seven Lakhs) was explored and examined by me. The then Vice Chancellor had recommended the proposal to initiate Disciplinary proceeding under Rule 14 (Procedure for imposing major penalties) of the CCS (CCA) Rules, 1965 against the those are involved and found guilty. File bearing No. 4/15/2018/DIPSAR on the Subject: "Adjustment of advance amounting to Rs.47,56,000/- for purchase of M&E in the year 2014-15" along with other record was forwarded to Department of Training & Technical Education being Administrative Department for further necessary action.
