



ORDER

1. This is an order on first appeal filed on-line vide registration-numbers CMOFC/A/2024/60037 dated 13.06.2024, wherein the appellant has stated that no response within the time limit by the PIO on his on-line RTI application registered as CMOFC/R/2024/60196 dated 22.04.2024.
2. I have gone through the records. It is observed that PIO, CM Office on 23.04.2024 had transferred on-line RTI application to PIO, Delhi Subordinate Services Selection Board (DSSSB) under section 6(3) of RTI Act, 2005 as the queries related to that department. Thus, PIO CM office responded timely.
3. Section 6(3) of RTI Act, 2005 states that public-authority, which is not concerned with the requested information, shall transfer the application to such other public authority which hold the information or to the authority to which the subject matter is more closely connected. As such, PIO has responded in accordance with provisions of RTI Act, 2005.
4. However, part information sought also pertains to DTTE for which the PIO, CMO should have transferred the application to the PIO, DTTE. PIO, CM Office is directed to transfer the application u/s 6(3) of the RTI Act, 2005 to the PIO, DTTE within 05 days of issue of this order.
5. Further, status of the online RTI application/1st appeal filed can be viewed by the applicant by clicking on View Status.
6. The appellant may, if so desire, file first appeal directly with transferee department/s in case of 'Nil' or unsatisfactory response as the information rests with transferee Department.
7. Appeal is disposed of accordingly with above direction.
8. The appellant may, if so desires, file second appeal under section 19(3) of RTI Act within 90 days of receipt of this appeal-order with Central Information Commission, CIC-Bhawan, Baba Gangnath Marg, New Delhi-110067.
