



Governor, Delhi has approved the decision of Cabinet No. 2750 dated 03.10.2019, for implementation of the grant of revised pay scales to teachers of Universities, Degree level Technical Colleges & Polytechnics (Renamed as Institute of Technology) under Department of Training and Technical Education, Govt. of NCT of Delhi on the recommendations of the University Grants Commission (UGC) with the concurrence of Internal Finance Decision vide Dy. Further Hon'ble LG has also approved the Cabinet decision regarding any clarifications/instructions issued by UGC/AICTE in continuation of these guidelines from time to time. 
