





F.Pr.COA/Misc/23/2105 dated 11-10-2024 on 11-10-2024 through WhatsApp at 1-06 pm directing me to appear before Internal Complaint Committee (ICC) at 2 pm on anonymous complaint which is enclosed as **Annexure 1**. In spite of request by me to the Chairperson, ICC vide letters dated 11-10-2024, 16-10-2024, 18-10-2024 and 28-10-2024 to provide copies of signed complaint and other documents so that I can defend myself, I have not been provided any documents. Finally, I have received one letter from the Chairperson, ICC vide F.no. COA/ICC/2024/2277-79 dated 28-10-2024 that all correspondences as per recommendation of the Committee have been sent to the Secretary, DTTE and I may seek same from the office of DTTE (Hq) which is enclosed as **Annexure-2**. So this matter has become a matter of my life and liberty.

6. Video recording of camera installed inside Principal, College of Art, New Delhi from 11-10-2024 till 28-10-2024 where the proceedings of ICC was conducted
