

Sir,

1. The undersigned applicant sent an RTI application to the PIO, DTTE, DTE, Directorate of Education on 16 Nov. 2018 seeking certain documents and information as enumerated under the ibid application.
2. In response to my said application, I received a communication from your high office requiring me to pay Rs. 345/- on account of photostat charges being 177 pages.
3. On 04.2.2019, when the applicant physically visited the office of the PIO (RTI Branch), I came to know that the documents were not as per my requirement and I then examined page by page and noticed that most the documents were not correct and I immediately lodged a protest/objection requesting the PIO to furnish the correct documents at the earliest.
