- The question should primarily relate to one Department only {(Rule 31 (xxii)}. Further, it should not be excessively lengthy (Rule 31 (iii)) nor information of too many details be asked for (Rule 31(xii)). In the event of non-conformity, the question may be disallowed or returned to the Hon'ble Member for improvement or amended by the Assembly Secretariat.
- 2. Hon'ble Members may kindly note that if notice of question is received after the last date and time in respect of various departments vide col. No. 3 and 4, such a notice shall stand disallowed. The time for receipt of notices shall be upto 3.00 P.M. on the last date of receipt of questions for departments as shown in column 4 above.
- 3. Where the questions draw a reference to a news item published in a national or local daily, the question in order to be admissible must be accompanied by the relevant clipping of the news items. The questions not accompanied by relevant clippings are likely to be disallowed.

- 6. Ballot will be held in the room of the Secretary (Room No.-54) as per schedule indicated Hon'ble Members are welcome to participate in the balloting.
- 7. Members may kindly note that notices of questions relating to day-to-day administration and functioning of Municipal Corporation of Delhi may not be entertained. The same are liable to be disallowed under Rule 31 (xiii).

#### **SPECIAL MENTIONS UNDER RULE 280:**
