In terms of the Articles of Association of the company, the Central Government being a shareholder of the Company shall at all times maintain not less than fifty one percent of the issued capital of the company. Considering the shareholding pattern, IDBI Bank Ltd. has been categorized under a New Sub-Group "Other Public Sector Banks."
