**C I R C U L A R**

A proposal was sent to Finance Department regarding payment / admissibility of Travelling Allowance (from residence to temporarily place of duty) to those who were deputed for Election Duty for the Delhi Assembly Election-2013 in various training cells of different constituencies. Finance Department, GNCTD has clarified the matter as under:-

***"that Travelling allowance is not admissible for the journey performed by officers/officials from their residence to the temporary duty point. However, they are entitled to Travelling Allowance, provided they performed any local journey in connection with official duty from the temporary duty point, which will be regulated as per SR-71".***

Therefore, All the Principal/Head of Office are hereby requested to settle the Travelling Allowance claims for election duty as per opinion given by the Finance Deptt., Govt. of NCT of Delhi. The cases already settled may also be reviewed accordingly.
