**Sub:- Implementation of CIC decision no. CIC/SG/C/2010/001294/14035 dated 11/08/2011 regarding uploading of Delhi Gazettes on the Website of Departments of Govt. of NCT of Delhi.**

In continuation of this department's Circular of even no. dated 09/08/2011 regarding uploading of Delhi Gazettes on the Website of Departments of Govt. of NCT of Delhi. I am directed to inform that the CIC in its decision mentioned above has directed as under:

"All gazette notifications issued after 15/08/2011 by all the departments, autonomous bodies, corporations and local bodies under the Govt. of Delhi shall be displayed on the website of the Govt. of Delhi. It shall also be ensured that the following schedule will be followed for displaying the earlier gazette notifications:

1. Gazette Notifications from 01/01/2011 to 14/08/2011 before 01/10/2011
2. Gazette Notifications from 01/01/2010 to 31/12/2010 before 01/11/2011
3. Gazette Notifications from 01/01/2009 to 31/12/2009 before 01/12/2011
4. Gazette Notifications from 01/04/2008 to 31/12/2008 before 31/12/2011

The Respondents shall send a compliance report of the above directions to [rimonitoring@gmail.com](mailto:rimonitoring@gmail.com) by the 31<sup>st</sup> December 2011. The Report must include:

1. The details of standing instructions issued.
2. Measures put in place to ensure regular updating of the information uploaded on the website.
3. The exact web link where the information is available".
- (2.) Since Gazette Notifications are issued by departments concerned necessary action may be taken to implement the abovementioned direction of CIC by uploading Gazette Notifications in the website of department, Specific link "Gazette Notifications" may be created in the website..
- (3.) Technical Support may be obtained from department of IT.
- (4.) An action taken report in this regard may be sent to this department by 15/09/2011, 15/10/2011, 15/11/2011 and on 15/12/2011, so that a consolidated report may be sent to the CIC.
