For instance if I come in morning 8'0 clock in morning then I can go only 8 or nearby 8p.m.... So it is my urg to you do something for us... If we will go to the human resources department of hotel then what they say " hotel me aane ka toh time hota h jaane ka nhi "...they never understand the condition of trainee and their families... And if we will go to the department then they say you can leave the training... Therefore the reason is no one go to the higher authorities because trainee spend a lot of money on their hotel management... I really hope RTI department is going to take action against this.... I hope my name won't be disclose otherwise me and my training will be in trouble.... And I also need the revert from RTI department then I can come to know of my RTI application... kindly revert... And specially this rti send to 4 star and 5 star hotels to their general manager.... And I also need the copy of my RTI....


