90 The Academic Session 2014-15 is ending on 31/07/2015. As per past practice the Deptt. every year continue the services of Contractual Instructors as per functional requirement of Institute after giving a break of one day.

91 In this regard it is submitted that annual performance report of all CCIs was sought from the Principals of all Institutes for continuation for the next academic session i.e. 2015-16. After scrutiny of the annual performance report of all CCIs (total 301), the performance reports on following CCIs are not found up to the mark:

92 In this regard it is submitted that some of the CCIs are rated as AVERAGE by the concerned Principals and only one recommendation is found continue for the next academic session. While in some of the institutes because one side Principals are rating the performance of CCIs as AVERAGE on the other side they are recommending the continuation of CCIs for the next session. In that context, it is stated that IIS/BIC being primary institute, the mean for imparting training/skills to the youth who are reading should be upto the mark i.e. their performance should be at least GOOD. It is not very good or exemplary. Therefore, faculties who have been rated POOR and AVERAGE should not be considered for continuation for the next session irrespective of the recommendation of the Principals. Copy of the performance reports of above mentioned CCIs are enclosed at page 12/C to 126/C.

93 Further it is submitted that the file for continuation of all CCIs except Employability Skills was sent to Finance Deptt. for approval. Though Finance Deptt., GNCTD has approved the continuation but due to some doubt regarding remuneration, the file is under submission to Finance Department, GNCTD. Hence, it is proposed that we may continue the services

of all the CCs (save those except above mentioned 15 officials and Employability Skills) in the table. The continuation for Instructors for Employability Skills will be approved when the approval from FD, GNCTD is received for which a separate file is under submission to Finance Department, GNCTD.

94 In view of the above, it is suggested that:

1. The services of 15 CCs mentioned in the above table may be terminated with immediate effect.
2. The Principals may be allowed to continue all those CCs provisionally with a grant of 6 months period whose services are essential and functional to the school with the direction to strictly adhere to the functional requirements of the job. These include those who have already been examined for the various other important duties. Principals are requested to fill up CCs on functional requirements and their details may be submitted with illustration.
3. The continuation for Instructors for Employability Skills may be approved and when the approval from FD, GNCTD is received.
