



Subject: Seeking information under RTI Act, 2005.

Sir,

I had submitted several complaints concerning corruption in CET conducted by Sh. L. S. Negi HOD/CDC Principal of Aryabhatt Polytechnics under the Department of Training & Technical Education (DTTE), GNCT of Delhi. The then Pr. Secretary (TTE) found lot of substances in the documents (enclosed by me with my complaints) about procedural irregularities & Corruption. To this, an enquiry committee was set up as informed by the then Special Secretary/Director (TTE) Sh. Arun Mishra and after preliminary enquiry a Special Audit was carried out by GNCT of Delhi. Special Audit report revealed many financial irregularities/corruption in the expenditure incurred during CET-2013. I have also submitted complaints to ANTI-CORRUPTION BRANCH (DIRECTORATE OF VIGILANCE) Govt. of National Capital Territory of Delhi. The ACP/Admn. for Addl. Commissioner of Police, Anti-Corruption Branch forwarded the complaints to the Director (TTE) for taking necessary action and reports to his office immediately, if corruption angle is found (Vide letter No. 1132/OC-48414/SO/ACB dated 26.02.2014, letter No. 2057/OC-99614/SO/ACB dated 02.05.2014 & letter No. 2357/OC-1208114/SO/ACB dated 22.05.2014 etc.). The corruption/financial irregularities are shown in the Special Audit Report of GNCT of Delhi. It appears that the corruption/financial irregularities have neither yet been reported to the said Anti-Corruption Branch nor any action has been taken by Additional Director (TTE), Director (TTE), even Audit Deptt. said that now TTE deptt. wants to settle the advance of Sh. L. S. Negi by including such bills/vouchers which are not signed by Dy. Controller, CET-2013.


1. Please provide the certified copies of SHOW CAUSE NOTICE with all documents issued by DTTE/DKDF to Sh. L. S. Negi, HOD/CDC Principal of Aryabhatt Polytechnics/ Controller CET-2013.
2. Please provide the certified copies of reply of SHOW CAUSE NOTICE with all documents given to DTTE/DKDF by Sh. L. S. Negi, HOD/CDC Principal of Aryabhatt Polytechnics/ Controller CET-2013.
3. Please provide the certified copies of all bills/vouchers received by DTTE/DKDF in response to SHOW CAUSE NOTICE) given to Sh. L. S. Negi, HOD/CDC Principal of Aryabhatt Polytechnics/ Controller CET-2013.
4. Please inform either all the bills/vouchers submitted so far by Sh. L. S. Negi against an advance of Rs. 85,00,000/- are duly signed by all the four officers including Dy. Controller CET-2013 nominated by the then Secretary (TTE) Sh. Rajender Kumar (presently Pr. Secretary to Hon'ble C. M. GNCTD, Delhi) for affixing signature on all the bills/vouchers against the advance of Rs. 85,00,000/- issued for CET 2013.
5. Please inform background/documents/decision based upon which now Treasurer (DKDF) & Member Secretary (DKDF) etc. accepting such bills/vouchers (against an advance of Rs. 85,00,000/- given in CET 2013 to Sh. L.S. Negi) which are not signed by Dy. Controller, CET-2013. Since the then Pr. Secretary (TTE) Sh. Verma ji was full agreed that all bills/vouchers must be signed by Dy. Controller CET-2013, needless to say that many financial irregularity were pointed out by him being monitoring authority of many activities.

of CET-2013 and signing authority of bills/vouchers of CET-2013, due to which he was relieved by Sh. L. S. Negi from CET before checking/signing all the bills/vouchers against advance of Rs. 85,00,000/-.

6. Please provide the name and designation of all the officers who had given permission to accept such bills/vouchers (against an advance of Rs. 85,00,000/- given in CET-2013 to Sh. L.S. Negi) which are not signed by Dy. Controller, CET-2013. Since the then Pr. Secretary (TTE) Sh. Verma ji was fully agreed that all bills/vouchers must be signed by Dy. Controller, CET-2013.
7. Please provide certified copies of the Report/Letters sent by DTTE to ANTI CORRUPTION BRANCH (DIRECTORATE OF VIGILANCE) Govt. of National Capital Territory of Delhi in compliance of the ACP/Admn. for Addl. Commissioner of Police, Anti-Corruption Branch **letter No. 1132/OC-48414/SO/ACB** dated 26.02.2014, letter No. 2057/OC-99614/SO/ACB dated 02.05.2014 & letter No. 2357/OC-1208114/SO/ACB dated 22.05.2014 etc.
