- Reply 1 : Department of DTTE is running 11 nos. of Government Institutes, 01 Govt. Aided Institute and 07 Pvt. Managed (BTE affiliated) Institutes for Diploma Level Courses in Delhi. As per the Information Bulletin 2015, the total numbers of seats in first year of all disciplines in these Institutes are 5293.
- Reply 2 : The Delhi Govt. intends to start one new Govt. Institute from this academic year i.e. 2016-17 at Rajokari, as a result of which approximately 120 nos. of new seats may be added subject to AICTE approval.



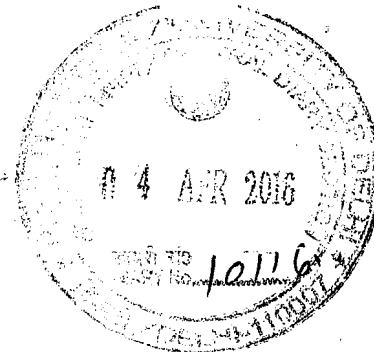
