

C.M. and a copy of the said letter also sent to me **without annexure of status report**. Said letter dated 01.02.2016/ 02.02.2016 sent to the O.S.D. to Dy. C.M. with reference to his letter No. DY. Cm/201569596 dated 03.06.2015. Hiding the status report and the finding of the committee to me (being complainant causing inquiry committee constituted) made clear that status report and findings of the committee submitted to the OSD to DY.
